

# Chair, Department of Psychiatry

## Location & Compensation:

- Experience to promote and sustain innovation and collaborative partnerships across all affiliated partners;
- Accomplished clinician who is in good standing with the Royal College of Physicians of Canada (FRCPC), or equivalent;
- Candidates must be eligible for a university rank of Associate or Full Professor;
- Eligibility for medical licensure in Ontario; and
- Fluency in one official language with at least a passive knowledge of the other.
